I believe these candid writings have helped all our Shareholders to have a better understanding of our corporation's operation and the importance of our employees and dedicated volunteers.

Our employees are the everyday work force of our corporation and many of us take them for granted, as I did in the past, until I had the privilege of working very closely with them daily, for the last 3 years. Carefree's daily operations starts with them, they are responsible for the administrative duties of our corporation, the general maintenance on the campus grounds and they are always available to assist the Board when needed. As long as Carefree maintains a great working staff, there will never be a need for a Management Company and we will remain self-governed and successful. Please, remember this fact before you make quick judgements or criticize our employees. Most negative opinions come from Shareholders who have no understanding of how our corporation operates.

I cannot predict the future but I leave knowing that our hard work accomplished over the past three years has taken us from corporate bankruptcy to a path of financial solvency. That journey came with much pain and hurtful attacks on our Board, largely instigated by former board members who were derelict in their fiduciary duties; they were not transparent, they mislead our Shareholders, and they put friendship before duty, which made it hard for our Shareholders to believe truth. I now understand that adage "Don't shoot the Messenger"; I was only the Messenger. "Forget the past, move forward" is echoed by some but as history teaches us we must never forget the past because understanding the past and the missteps of the previous leadership protects Carefree's future and prevents repetition of this erroneous behavior. I reflect on these past three years and can see the incremental victories that moved our community forward. The positive steps that moved us, from climbing out of a deep financial hole, was our focus on our fiduciary role to protect 1614 households. I have always been mindful that

"fiduciary" is not just a "fancy" word, it carries a huge responsibility of trust, owed entirely to the Shareholders that elected us to be Carefree's guardians. I have always served our community fairly, and treated our Shareholders and residents with respect while ensuring that our community operated in full compliance with our governing documents and all applicable law. This year's Carefree Christmas/Hanukkah gift came in as a \$46,000 savings for our yearly Lawn and Snow maintenance contract; this savings offset other normal operating costs that have risen due to inflation. So the good news for all or Shareholders is that your yearly HOA dues will not increase, they will remain at \$600 a year. This could not have been done without the continual cuts in our overall operating expenses and, thankfully the additional funds raised by our volunteers throughout the year. Keep in mind that times are changing, and our events are less attended, therefore, in order for Carefree to continue keeping the HOA yearly dues at a nominal fee, we must come up with future creative fundraising ideas. Our surrounding communities receive regular income from different types of permanent funding sources that supplement their operating budgets. It is time for affirmative action, expenses will not fall, costs will continue to rise, and all 1614 households must share these costs.

I know 2025 is going to be a very exciting year for Carefree. According to our Falcon Reserve Study, we are scheduled for some major improvements to our Carefree Campus. Starting in early spring, we will be getting a new parking lot, tennis/pickle ball court, sidewalks, curbing, new pool furniture, landscape improvements, etc. These capital improvements will spruce up our campus grounds, will help to protect against slip and falls, and with a smile, I note the improvements will also help to increase the value of our homes. But the BEST NEWS is that all of these major improvements come at NO additional cost for our Shareholders due to the 2024 Special Assessment replenishment to our Capital Reserve Fund. We are fully funded for all these major capital improvements.
